Minutes of December 15, 2017

The December 15, 2017 meeting of the Burlington County Tax Board was held at the Burlington County Administration Building in the Freeholder's Board Room 49 Rancocas Road Mount Holly, NJ at 9:00am.

Commissioner Lamon opened the meeting pursuant to notices advertised and posted in conformance with the "Open Public Meeting Act" Chapter 231. Everyone present stood for the Pledge of Allegiance.

Commissioners Chatzidakis, Kennedy, Kersey, Lamon and Summerville were all present for this meeting and answered roll call.

Commissioner Kennedy made a motion to approve the meeting minutes from the November 3, 2017 Board meeting, Commissioner Kersey seconded the motion. Commissioner Chatzidakis abstained from voting, all other Commissioners voted aye.

Commissioner Chatzidakis made a motion to approve the assessor appeals, Commissioner Kennedy second the motion, all Commissioners voted aye.

Added/Omitted Tax Appeals were heard for the following Municipalities: Maple Shade Twp, Mansfield Twp, Westampton Twp and Moorestown Twp

Commissioner Kennedy made a motion to approve all settlement of stipulations, Commissioner Summerville seconded, all Commissioners voted aye.

Business before the Board:

Commissioner Kersey made a motion to approve the reassessment application for Edgewater Park Twp; Commissioner Chatzidakis seconded the motion, all Commissioners voted aye.

The report from Tax Assessor Jim Duda, Edgewater Park Twp will be discussed at the next meeting on December 19, 2017; it was received too late for review.


Public Comments:
