WHEREAS, on August 17, 2018 Governor Murphy signed into law A-538/S2257, becoming P.L. 2018, c.94, which permits a County governing body, with approval of the County Board of Taxation, to revise the real property assessment calendar; and

WHEREAS, P.L. 2018, c.94 took effect immediately permitting a County to adopt the revised real property assessment calendar that is used in the Real Property Assessment Demonstration Program without the requirement to participate in the Real Property Assessment Demonstration Program; and

WHEREAS, the County Board of Taxation held consultations with the County's municipal assessors during open public meetings on February 14, 2019 and March 5, 2019; and

WHEREAS, implementation of the alternate assessment calendar shall begin on October 1 next following the adoption of the Board of Chosen Freeholders of the County of Burlington resolution; now, therefore, be it

RESOLVED, by the Board of Chosen Freeholders of the County of Burlington that the Burlington County Board of Taxation on March 10, 2020 the Board adopts the Real Property Alternate Assessment Calendar as per P.L. 2018, c. 94; and, be it

FURTHER RESOLVED, that the tax board administrator forward a copy of this Resolution to the Board of Chosen Freeholders of the County of Burlington not later than the seventh business day next following the adoption of the resolution and to the Director of the Division of Taxation.
