## AUDIT FINDINGS

### **Narrative:**

An audit of the Burlington County Juvenile Detention facility in Pemberton, New Jersey was conducted on March 21st and 22nd, 2019 by Candy Snyder, a certified PREA auditor, and assisted by Mark Snyder, an auditing assistant.

An entrance meeting began with Superintendent Lynn Arnieri. Following the entrance meeting we conducted the facility tour. The auditor then began interviewing specialized staff. Suitable and private accommodations were made for the auditor to conduct interviews. The auditor was not limited in any way from speaking with staff or youth or inspecting any area of the facility. The auditor was given access to the facility at all hours of the day in order to conduct interviews with staff on all shifts. The superintendent and her staff were extremely polite and accommodating throughout the audit.

As BCJDC is small facility and key staff hold multiple positions. Lynn Arnieri was interviewed as the Superintendent, Human Resource Manager, the PREA Coordinator, and staff the conduct unannounced rounds.

The auditor conducted a review of the application and hiring process and employee background checks. The auditor reviewed investigative files.

Ms. Arnieri provided a copy of the staff schedule. The auditor randomly selected twelve (12) staff and conducted interviews of staff covering all shifts, varying degrees of longevity, diverse job classifications and staff who worked within varying areas of the facility. The auditor asked specialized questions of those line staff that perform screenings, perform searches, who are first responders, and staff who conduct the intake process.

The auditor interviewed all youth at the facility for a total of 14 youth interviews. There were no residents who were disabled or who were limited English speaking to be interviewed and there were no residents who identified as LGBTI. The facility states that it does not use isolation and this was confirmed through direct observation and through interviews.

An exit briefing was held and the auditor provided a preliminary finding of each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the audit report. The auditor thanked the Superintendent for the hard work and their commitment to keeping youth under their care safe.

**AUDIT FINDINGS**

**Facility Characteristics:**

The facility is located in Pemberton Township in Burlington County, New Jersey. The original facility was constructed in 1968 with a building expansion project completed in 1991. The facility is comprised of two buildings and a secure, fenced-in outdoor recreation area. The main building consists of administrative areas, intake area, dayroom, dining room, kitchen, and two housing wings. Wing A was originally for female youth. However, it was recently remodeled with a door dividing the wing so that male youth can be housed in the rear of the wing when needed. Wing A has seven (7) single rooms that consist of a bunk and a combination unit toilet/sink. The combi unit is situated within the room so that the youth has privacy when toileting. There are two showerheads within the girls’ shower room. However, staff and youth confirm that they are showered singly. Wing B is for male youth and has 17 single rooms. The room layouts are same as in Wing A. On the boys wing there are three showerheads within the boys’ shower room. They have modified by adding shower divider curtains so that the boys have privacy while showering. Boys are showered two at a time with a male officer positioned at the door for supervision unless special considerations are made for showering singly.

There is a gymnasium for indoor recreation and a modular building that was added in 2000 to increase space for educational services. Throughout the tour of the facility, the auditor noted PREA posters and the required posted Audit Notice.

<b>115.311</b>	<b>Zero tolerance of sexual abuse and sexual harassment; PREA coordinator</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The Burlington County Juvenile Detention Center (BCJDC) has a thorough PREA policy covering all aspects of the PREA Standards and mandating zero tolerance. The facility had designated the Superintendent as the PREA Coordinator and she has addressed every standard in both policy and procedure. Supervising JDO Ivanisik assists with PREA Compliance.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The facility does not contract for the confinement of its residents with other private agencies/entities.</p>

115.313	<b>Supervision and monitoring</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The BCJDC documents their staffing plan. They require seven officers during the day shift and six officers at night. They complete an annual review each year to evaluate the staffing plan, the camera surveillance systems, staff coverage, adequacy of supervision and prevailing staffing patterns over the past year. They maintain a 1:8 staff to resident ratio during waking hours and a 1:16 staff to resident ratio during sleeping hours. This ratio is required by the New Jersey Juvenile Justice Commission (NJJC). Staff shortages are typically handled through overtime to ensure posts do not go unfilled. However, they had deviations to their staffing plan for four days at the beginning of the year due to staff unexpected leave of absences. The facility deviated from their daily schedule in order to properly supervise youth with the required youth to staff ratios. They reported the deviations to the NJJC and provided the auditor with their communications in remedying their staffing issues. They have been able to maintain ratios as the population numbers have been down.</p> <p>The BCJDC Superintendent conducts and documents unannounced rounds to identify and deter staff sexual abuse and sexual harassment. The auditor verified that unannounced rounds are conducted at varying times of the day to include night shifts, weekends and holidays.</p>



<b>115.315</b>	<b>Limits to cross-gender viewing and searches</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The facility does not conduct cross-gender strip searches, cross-gender pat-down searches or cross-gender visual body cavity searches. This was verified through interviews with both staff and youth. The facility did not have any exigent circumstances regarding strip searches to log. In regard to the initial entry and strip search of a youth, the staff member conducting the strip search positions them outside of the shower area so that they can be viewed by the staff member in the control room while able to direct the search and still maintain the youth's privacy.</p> <p>The facility has good policies and procedures in place that enable residents to shower, toilet and change clothing without staff of the opposite gender viewing them naked. Although staff of the opposing gender are very rarely on the youth's housing wing, they do announce their presence when entering. These procedures were confirmed also through staff and youth interviews. There have been no instances of transgendered or intersex residents admitted to the facility. However, the BCJDC staff were aware of the responsibility of determining sex solely through professional conversation or through medical records or through part of a broader medical examination by a medical practitioner. Staff are trained on how to conduct a cross-gender pat search if an emergency circumstance requires it. It was confirmed through interviews with both youth and staff that this is highly unlikely to ever occur.</p>

	<b>Auditor Discussion</b>
	<p>The BCJDC has a contract with Voiance to provide telephonic interpretive services that can assist in the intake process, screening process, education on how to report and if need be, translate during the investigative process. The school district assists in assistance with youth who may have disabilities so that they may fully participate in protection efforts. The facility does not use residents to interpret for other residents.</p>

<b>115.317</b>	<b>Hiring and promotion decisions</b>

	<b>Auditor Discussion</b>
	The auditor reviewed personnel files and interviewed the Superintendent to verify compliance with the standard. The facility has performed background checks and Child Abuse Record Information (CARI) checks at the time of employment. They also run the background check again every five years. They ask three questions regarding previous sexual misconduct as per the standard on their application and they require new hires to affirm that they have a continuing duty to report.

	<b>Auditor Discussion</b>
	Unit A was recently remodeled with a door dividing the wing so that male youth can be housed in the rear of the wing when needed. The administrators consider the ways in which to enhance their efforts and abilities to protect residents from sexual abuse through the use of electronic monitoring and video monitoring. They have added an additional ten cameras in key areas. They have also upgraded all LED fixtures to improve lighting in all areas. Additionally, they have electronic monitoring in which they can hear (but not record) the conversations within rooms from the control room.

	<p data-bbox="252 168 901 201"><b>Auditor Overall Determination:</b> Meets Standard</p> <p data-bbox="252 246 526 280"><b>Auditor Discussion</b></p> <p data-bbox="252 324 1484 952">As soon as a sexual abuse is reported the protocol is to call both the Division of Child Protection and Permanency (DCP&amp;P) and the Burlington County Prosecutor’s Office. The Burlington County Prosecutor’s Office Sexual Assault/Child Abuse Unit (SACA) uses special investigative techniques, as well as a different investigative and prosecutorial approach to successfully investigate, prosecute and care for the child victim. Detectives receive specialized training in interviewing the victims of sexual assault and physical child abuse. They have a multi-disciplinary approach that couples the detectives and prosecutors with mental health agencies, DCP&amp;P and educational and medical professionals. The purpose of this approach is to minimize the impact of the criminal investigation on an already traumatized child. The prosecutor’s office has a SART/SANE Coordinator that is responsible for providing for the medical forensic exams to victims of sexual assault. The coordinator is the liaison to the four participating SART hospitals, maintains chain-of- custody for all evidence, writes policies and procedures, maintains case files, communicates with law enforcement agencies and oversees the response of the Sexual Assault Response Team. In addition to conducting exams of victims who are 13 or older, SANE nurses conduct acute pediatric exams as well.</p> <p data-bbox="252 1008 1476 1220">The BCJDC has an Memorandum of Understanding (MOU) with a local advocate from a rape crisis center, Contact. Contact also has an agreement with Burlington County in connection with the SACA Unit. Contact is the local advocacy agency in Burlington County. They have trained advocates that provide counseling to survivors. They also provide accompaniments to Burlington County hospitals, police stations and courts.</p>

<b>115.322</b>	<b>Policies to ensure referrals of allegations for investigations</b>
	<p data-bbox="252 1417 901 1451"><b>Auditor Overall Determination:</b> Meets Standard</p> <p data-bbox="252 1496 526 1529"><b>Auditor Discussion</b></p> <p data-bbox="252 1574 1460 1787">The PREA policy requires that upon receiving a report of sexual abuse procedures are in place to always notify the prosecutor’s office and DCP&amp;P for every incident of sexual abuse. For incidents of sexual harassment or do not rise to the level of sexual abuse are referred to the Superintendent or the PREA Coordinator for an administrative investigation. The investigation policy is posted on the BCJDC website.</p>

<b>115.331</b>	<b>Employee training</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The BCJDC provides PREA training to all staff and documents through employee signature, that employees understand the training they have received and list the components of the training. The training was evident throughout the interviews in that they are familiar with how to report incidents of sexual abuse and harassment, that they understand the indications that a resident may be experiencing sexual harassment or sexual abuse and that they do not treat LGBTI residents any differently than other residents. All staff were able to identify that it is criminal sexual assault if they were in a supervisory or disciplinary position over the youth such as a staff, contractor, or volunteer at the juvenile detention center and that they are mandatory reporters of sexual abuse.

<b>115.332</b>	<b>Volunteer and contractor training</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	BCJDC provides PREA training to volunteers and contractors at a level that is dependent upon their level of contact with the youth. The training is documented and the auditor verified through interviews.

<b>115.333</b>	<b>Resident education</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The facility provides residents information on BCJDC's zero tolerance culture regarding sexual abuse and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment. This was evident through the interviews with youth. They also provide additional comprehensive education within ten days of intake in person. This more comprehensive training includes their right to be free from sexual abuse and sexual harassment, to be free from retaliation for reporting such incidents, and regarding the BCJDC's policies and procedures for responding to such incidents. This information is continuously and readily available through posters throughout the facility as well as in the BCJDC Juvenile Rule Book. The BCJDC maintains documentation of resident participation in both of these education sessions.

<b>115.334</b>	<b>Specialized training: Investigations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The Burlington County Prosecutor's office conducts sexual abuse investigations and they have received training in conducting such investigations in confinement settings. The Superintendent and the PREA Compliance Manager are the administrative investigators for the facility. They completed the NIC course PREA: Investigation Sexual Abuse in a Confinement Setting.

<b>115.335</b>	<b>Specialized training: Medical and mental health care</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The health services administrator is very knowledgeable in PREA. Staff are required to complete PREA training through their health streams on-line learning site. This training includes how to detect and assess signs of sexual abuse and sexual harassment; how to preserve physical evidence of sexual abuse; how to respond effectively and professionally to victims of sexual abuse and sexual harassment; and how and to whom to report allegations or suspicions of sexual abuse and sexual harassment.

<b>115.341</b>	<b>Obtaining information from residents</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The BCJDC completes their screening process during the intake. It is typically within the first 24 hours, but no later than 72 hours of the resident's arrival at the facility and periodically throughout a resident's confinement. The facility maintains and uses information about each resident's personal history and behavior to reduce the risk of sexual abuse by or upon a resident. The auditor reviewed policy, youth screenings as well as conducted interviews to verify compliance with this standard.

<b>115.342</b>	<b>Placement of residents</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>BCJDC uses screening information obtained to make housing, bed, program, and education for residents with the goal of keeping all residents safe and free from sexual abuse. The facility has had no transgender or intersex residents, but interviews indicate that a transgender or intersex resident's own views with respect to his or her own safety would be given serious consideration. All residents shower separately. The facility does not place lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive. The facility indicates through interviews that they will consider on a case by case basis assignment to a living unit whether the a placement would ensure the resident's health and safety, and whether the placement would present management or security problems. Facility procedure is to manage a resident's room placement rather than using isolation as a means for protecting the resident's safety.</p>

<b>115.351</b>	<b>Resident reporting</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>BCJDC provides multiple internal ways for residents to privately report sexual abuse and sexual harassment, or retaliation. Youth often speak with the social workers and have ready access. They can write a grievance (grievance forms are in the back of the resident rule book). Social Workers assist them in their calls and they can call whomever they choose. They have access to a phone and the numbers are posted near the phone for both Contact, a local advocacy organization and Division of Child Protection and Permanency (DCP&amp;P). The youth can speak with the nurse privately at any time by simply making the request. They also can speak with the Superintendent by making the request to any staff.</p> <p>Youth reported feeling very comfortable reporting directly to their staff or another person within the facility. They reported there is a grievance process. The staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly documents any verbal reports. The facility provides residents with access to tools necessary to make a written report.</p>

<b>115.352</b>	<b>Exhaustion of administrative remedies</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	Residents may submit a grievance alleging sexual abuse or harassment without submitting it to a staff member that is subject of the allegation. The grievance form is available and a blank form is also in the back of the youth's "Juvenile Rule Book". The youth does not have to complete any other prior steps in order to submit a grievance for an allegation of sexual abuse. There is no time limit on when a youth can submit a grievance regarding an allegation of sexual abuse. Staff and youth interviews confirmed their knowledge of how the grievance process can be used to report sexual abuse and sexual harassment.

<b>115.353</b>	<b>Resident access to outside confidential support services and legal representation</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	BCJDC has a Memorandum of Understanding (MOU) with Contact, a local rape crisis center. There are posters throughout on how to access this organization. The auditor dialed Contact from the facility on the youth phone. Contact verified that they provide services to BCJDC. The BCJDC provides youth with reasonable and confidential access to their attorneys and parents. In addition, all youth interviewed reported that they had contact with their families regularly. If the youth is involved with the Department of Children and Families, they may already be assigned a Care Management worker who assists them in accessing services through Care Management Organizations (CMO's) that provide a range of treatment and support services to children.

<b>115.354</b>	<b>Third-party reporting</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The BCJDC posts on their website how to report sexual abuse and sexual harassment on behalf of a resident at <a href="http://www.co.burlington.nj.us/1176/Juvenile-Detention-Center">http://www.co.burlington.nj.us/1176/Juvenile-Detention-Center</a> . In addition this information is available on the bulletin board when visitors enter the facility.

<b>115.361</b>	<b>Staff and agency reporting duties</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>BCJDC requires all staff to report immediately any knowledge, suspicion, or information regarding an incident of sexual abuse or sexual harassment that occurred in a facility, retaliation against residents or staff who reported such an incident; and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation.</p> <p>Apart from reporting to designated supervisors or officials and designated State agency, staff are prohibited from revealing any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation, and other security and management decisions.</p> <p>Medical and mental health practitioners are required to report sexual abuse to designated supervisors and officials as well as to the designated State service agencies. Such practitioners are required to inform the residents at the initiation of services of their duty to report and the limitation of confidentiality. This procedure was confirmed by the health services administrator.</p> <p>The staff reports all allegations of sexual abuse and sexual harassment, including third-party and anonymous reports, to designated investigators. Upon receiving any allegation of sexual abuse, the Superintendent or designee promptly reports the allegation to the DCP, the prosecutor's office, and to parents or legal guardian.</p>

<b>115.362</b>	<b>Agency protection duties</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>Through interviews with the Superintendent and random staff there is evidence to support that the facility requires all staff to take immediate action to protect the resident from imminent sexual abuse. There have been no instances that a resident was subject to risk of imminent sexual abuse.</p>

Measures include housing changes, removing contact of alleged staff/resident abusers and emotional support services for those who fear retaliation. Administrative investigations include efforts to determine whether staff actions/failures contributed to the abuse documented through written reports that will include physical/testimonial evidence, credibility reasoning assessments and investigative facts and findings. The auditor reviewed the investigations and discussed with the Superintendent the increase of youth-on-youth sexual harassment reports. In reviewing investigative reports it appears they may be deeming one single, isolated, derogatory phrase by a youth toward another youth as sexual harassment. Many of the reports consisted of a resident who said another resident said something derogatory. Most of the accusations were unsubstantiated as there were no witnesses to the isolated statement. The definition of sexual harassment is REPEATED and unwelcome verbal comments of a derogatory or offensive sexual nature. The accusation of one isolated statement from another resident could be done with the intent of manipulating the PREA reporting process to both tie up staff's time and be used to strike out against another youth.
