

41st ANNUAL JURIED ART EXHIBIT

ELIGIBILITY: Open to any artist who is 18 years or older.

RULES OF ENTRY: Artists may submit up to three (3) works of art in the form of collages, paintings, drawings, mixed media, and/or sculptures. No photography, computer art, crafts or painting copies. Work previously hung in a juried art show at Smithville Mansion will not be accepted. Please attach hooks and wire between a quarter and a third of the way down from the top of the frame leaving little slack so it will hang close to the wall. If an aspect of the piece prohibits wire, please address situation with curator, who will make final determination regarding installation. The exposed edges of unframed art must be harmonious with the overall appearance of the piece when hung. **No clip frames, center hangers or adhesive hooks...NO EXCEPTIONS TO THIS RULE.**

FEE: A \$20 non-refundable entry fee per artist. Make checks payable to **Treasurer, Burlington County.**

SALE OF ARTWORK: A 20% donation on the sale of exhibited works is required. The Burlington County Division of Parks staff does not handle art sales. Patrons interested in purchasing artwork will provide staff with their contact information, which will be forwarded to the individual artist who is responsible for handling the sale and submitting the 20% donation to the Division of Parks. All artwork must remain on display throughout the duration of the exhibit.
