




#### Sewer Service in Environmentally Sensitive Areas

Where a development has secured approval under the Municipal Land Use Law and possesses a valid wastewater approval, the site may be included in the sewer service area if consistent with that valid wastewater approval. This information was gathered in consultation with municipalities and property owners. The location of these developments are indicated on this map and keyed to a list of qualifying developments in *each municipal chapter*. Some of the sites included on this map were excluded due to a lack of valid approvals, and a review by DEP indicated exclusion was necessary.
