

TRANSPORT GUIDELINES

FOR DELIVERING SOLID WASTE TO THE BURLINGTON COUNTY RESOURCE RECOVERY COMPLEX

DO NOT RENT ANY SIZE VEHICLE

from U-Haul, Lowes, Home Depot, Ryder, etc. to deliver your solid waste to the landfill.

You will NOT be permitted to enter the facility.



- **State law requires that all commercial vehicles and/or vehicles with commercial license plates must have current NJDEP hauling decals in order to transport solid waste.**
 - A-901 Licensed Transporters (waste haulers, junk removal & clean out companies, etc.)
 - Self Generator Solid Waste Transporters (roofers, plumbers, electricians, landscapers, etc.)
- **Unless a resident is transporting waste from their own home and in a passenger vehicle, the vehicle used MUST have an NJDEP solid waste hauling decal.**

Additional Recycling Drop-offs at Convenience Center:

Shredded Paper Dropoff

Already shredded confidential papers done at home can be recycled at this permanent dropoff. All shredded paper must be delivered in clear plastic bags. It must be free of any non-paper items, like shredded credit cards or CDs.

TREX Plastic Wrap and Film Dropoff

For residents that wish to recycle their plastic bags, wrap and film. All material must be a #2 or #4 type plastic. It should stretch and not tear like paper, and be clean and free from any food residue. Examples of acceptable items include, bubble wrap, plastic shipping envelopes, case over wrap, pallet wrap/stretch film, plastic wrap, dry cleaning bags, etc.

Mattress Dropoff

For clean and dry mattresses and box springs only. Residents must weigh in at the Scale house and will be directed to the Convenience Center. Staff will determine if items can be recycled or disposed of as trash.

Mattress Fee Schedule

Mixed Units with Other Waste – Bulky waste fee (see reverse side for details) + surcharge \$13.50 per unit

Source Separated Mattresses or Box Springs - \$18.50 per unit.

THE FOLLOWING ITEMS CANNOT BE LANDFILLED:

- Bulk liquids
- Septic tank clean-out waste
- Radioactive waste
- Regulated medical waste
- Designated recyclables, including cardboard, **computers**, fluorescent lights, printers, fax machines, metal appliances, tires and **TVs**
- Leaves

RESOURCE RECOVERY COMPLEX FACILITIES

Scalehouse - Before entering the Complex, everyone must report to the scalehouse where you will be directed to:

Convenience Center - For small truck or car loads of waste to be manually unloaded into marked containers.

Computer/Television Dropoff -

Residents may bring computers/laptops, monitors, TVs, keyboards/mice/cables, printers, desktop printers/copiers, scanners, gaming consoles, radio/stereos (*no speakers*), VCR/DVD players, cameras, cell phones, telephones. No loose batteries or loose toner cartridges. Small businesses (*50 employees or less*) located in Burlington County must call (609) 499-1001 for approval.

Other Recycling Options - Check locally. Many towns have ewaste dropoffs. Goodwill donation centers also accept *non-working* TVs, monitors, and printers.

Bulky Materials Area for segregated loads of

- Scrap metal (white goods)
- Wood waste
- Asphalt shingles & tarpaper
- Tires

HOUSEHOLD HAZARDOUS WASTE FACILITY (HHWF)

For residential hazardous waste such as paint, solvents, pesticides, weed killers, pool and photo chemicals, fluorescent lights, ballasts and small fire extinguishers.

HHWF HOURS

OPEN:

Tuesday to Friday: 7am - 3pm

Saturday: 7am - Noon

Proof of county residency required

CLOSED ON MONDAYS

If a holiday falls on Monday, the facility will be closed on Tuesday.

Batteries - Rechargeable, lead acid, button, lithium batteries, **especially laptop batteries, should NEVER be put in trash or recycling; they can cause fires.**

Recycle at most stores that sell them or bring to HHWF. *Note: alkaline batteries are not hazardous and may be safely placed in the trash.*

Compact Fluorescent Bulbs (CFLs) -

CFLs contain mercury; bring unbroken bulbs to the HHWF for safe disposal.

The Home Depot and Lowes accept CFLs for recycling. They do not accept the long tube types of fluorescent lights. Take tube lights to the Household Hazardous Waste Facility for safe disposal.

* Appliances that contain Freon must be delivered uncompacted and separated from other metal. **IMPORTANT** - care must be taken in loading and transporting to insure lines remain intact.

** Four tire limit per customer.

Notice: All commercial vehicles hauling waste to the Complex for disposal must have a NJDEP vehicle registration. Additionally, any truck with a gross weight of 8,000 lbs. or more as noted on the vehicle registration, must also have a NJDEP registration.
