WHEREAS, after the solicitation of competitive proposals pursuant to N.J.S.A. 40A:11-4.1, titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), the Board of County Commissioners of the County of Burlington (the "Board"), awarded a contract per Resolution #2021-00596 dated October 27, 2021, to UIH Family Partners d/b/a The Father Center of New Jersey located at 17 West Broad Street, Burlington, NJ 08016, for the proposal titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), to provide employment and training services to eligible Burlington County public assistance recipients of GA/SNAP Funding (General Assistance and/or Supplemental Nutrition Assistance Program), for a total amount not to exceed \$87,500.00, for the contract period of November 1, 2021 through June 30, 2022, for the Department of Human Services, Division of Workforce Development Board; and

WHEREAS, the Department of Human Services, Division of Workforce Development Board recommends amending the contract titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), with UIH Family Partners d/b/a The Father Center of New Jersey, extending the contract period for one (1) year, to provide employment and training services to eligible Burlington County public assistance recipients of GA/SNAP Funding (General Assistance and/or Supplemental Nutrition Assistance Program), for the contract period of July 1, 2022 through June 30, 2023; and

WHEREAS, UIH Family Partners d/b/a The Father Center of New Jersey has agreed to extend the contract period for one (1) year, for the contract period of July 1, 2022 through June 30, 2023; and

WHEREAS, a First Amendment to the contract titled "WORK FIRST NEW JERSEY PROGRAMS & SERVICES 2021-2022" (RFP-21-0018-C), with UIH Family Partners d/b/a The Father Center of New Jersey is required to the extend the contract period from July 1, 2022 through June 30, 2023; and
